General Information:

Terms:

At the **November 4, 2025** Coordinated Municipal Election, four Trustee positions will be on the ballot. All Trustees terms are for four-year and those elected will be sworn in on January 12, 2026.

Meetings:

Regular Board of Trustee meetings are held on the 2nd and 4th Mondays of each month. Special meetings are held on an as needed basis. Newly elected Trustees will receive \$400 per month flat rate, regardless of the number of meetings held in a month.

Election Code:

The Town of Silt, a Home Rule Town, will be conducting the Regular Municipal Election on **November 4, 2025** according to Title 31, Article 10, Colorado Revised Statutes, the Municipal Election Code of 1965, C.R.S. §1-7.5-101 *et seq.*, and the Home Rule Charter. This election will be coordinated with Garfield County who will conduct the election by mail ballot, with ballots being mailed to all active registered voters of the Town of Silt.

Qualifications for Office:

- * Must be a registered elector;
- * Must be at least eighteen years of age; and
- * Must be a resident of Silt for at least twelve consecutive months immediately preceding the date of election

Nomination Petitions:

Candidates are nominated and elected by registered voters who reside within the Town limits. Candidates may begin to circulate nominating petitions on August 5, 2025, and they must be filed with the Town Clerk's office prior to 5:30 p.m. on August 25, 2025.

A Nomination Petition Form is included with this packet. The petition must be signed by at least twenty-five (25) registered electors who reside within the Town limits. Please plan on obtaining more than the 25 signatures should some of them be rejected. The Candidate must sign the Affidavit of Circulator and the Candidates Affidavit of Acceptance. If the circulator of the petition is someone other than the Candidate, they must sign the Affidavit of Circulator. Both documents must be notarized.

Each office of the governing body that is to be filled by the electorate shall be considered a separate office for the purpose of nomination. The State Statutes require, in addition to a signature, the signor's printed name. Each signature must be legible and every address is to be the street address, **NOT a post office box**. The circulator of the Nomination Petition Form **must witness all signatures**.

Ballot:

Candidates' names are placed on the ballot by lot. Names of all candidates who have submitted complete petitions will be placed in a basket and will be drawn one at a time to determine the order on the ballot. Names appearing on the ballot may include a nickname, but shall not contain any title or degree designating the business or profession of the candidate.

Election Judges:

Garfield County will be responsible for the hiring of election judges.

Voter Registration:

Residents may register to vote at the Silt Municipal Building, 231 N. 7th Street, from 7:00 a.m. until 5:30 p.m., Monday - Thursday. Voter registration is also available at the Garfield County Clerk's office in Glenwood Springs (the Courthouse) or the County Administration Building in Rifle. You can also visit www.GoVoteColorado.gov to register or update your registration. In-person voter registration is allowed up through Election Day.

Mail Ballots:

The election will be coordinated with Garfield County who will be responsible for mailing out ballots and tabulating votes. Ballots will be mailed to all active registered voters no earlier than October 14, 2025. Ballots may be mailed back to Garfield County in the envelope provided or hand delivered in the envelope provided to any external voting box located within Garfield County by 7:00 p.m. Election Day. There is a voting box located outside of the Silt Municipal Building, 231 N. 7th Street, Silt. If you are going to be out of town when ballots are mailed, and won't be back by Election Day, you can update your voter registration and include a mailing address for your ballot to be mailed.

Colorado Fair Campaign Practices Act:

The reporting requirements of the Fair Campaign Practices Act (FCPA) apply to all municipal candidates. All forms required by the Act must be filed with the Town Clerk. It is the responsibility of the candidate to become familiar with and follow the provisions of the Fair Campaign Practices Act. You can view the Campaign and Political Finance Manual by visiting the Secretary of State website at: www.sos.state.co.us. Just click on Campaign Finance on the Home page and the manual can be found under Help & Resources. **Failure to file the proper forms will result in the disqualification of a person as a candidate.** If you have any questions on filing, contact the Town Clerk/Designated Election Official.

Election Campaign Signs:

It is entirely up to each candidate to determine what type and how much campaigning he/she would like to do. If you should decide to put up political signs, please check the Town of Silt Municipal Code for sign code regulation for the guidelines to follow.

WARNING: IT IS AGAINST THE LAW

For anyone to sign this petition with any name other than one's own or to knowingly sign one's name more than once for the same candidate or to knowingly sign the petition when not a registered elector. Do not sign this petition unless you are a qualified elector. To be a qualified elector you must be registered to vote and eligible to vote in the Town of Silt elections. Do not sign this petition unless you have read or have had read to you the proposed nomination petition in its entirety and understand its meaning.

Per Silt Municipal Code Chapter 1.16 Section 1.16.030, elections shall be conducted in accordance with the Colorado Municipal Election Code of 1965. Petitions may be circulated and signed beginning Tuesday, August 5, 2025 (91 days prior) and ending on Monday, August 25, 2025 (71 days prior) to the day of election. Petitions shall be filed with the Town Clerk no later than Monday, August 25, 2025 at 5:30 pm.

Sign this petition only if:

- (1) you are registered to vote in Silt Municipal Elections and are qualified to vote for this candidate; and
- (2) you have not signed more nominating petitions than there are offices for which you are entitled to vote.
